Thankfully, by the end of the school

Philanthropy Recap

We decided to focus heavily on improving our philanthropy efforts during the 2019-2020 school year. Although our ability to host fundraisers and similar events on grounds was prohibited by the rise of COVID, we were able to adapt our plans to issues that existed beyond the Charlottesville area in order to maintain our progress in improving the chapter's philanthropy. One of the issues that gained a lot of media attention in 2020 was the systematic injustice against minorities in the U.S., more specifically the discrimination towards the black community. After meeting together over Zoom, we found that a large majority of the brotherhood was looking for a way to help these communities and to speak out against the oppression that was highlighted by the murder of George Floyd. We decided to focus our efforts to promote a social media fundraiser which raised \$6,500 for the Richmond Bail Relief, Campaign Zero, and the Central Virginia Legal Aid Society. While we aimed to find an issue that was affecting those nationwide, we wanted to support Virginia-based efforts to help the fight against racism in our own state.

For our Fall 2020 event, we held a fundraiser with Fabio's Pizza to support the UVA Hospital's Family Centered Care Program. This program assists the families of children undergoing cancer treatment at the hospital by providing them with goods such as gas vouchers and children's toys. We promoted this fundraiser to the members of the UVA community by word-of-mouth and social media, and Fabio's donated a portion of the proceeds to our charity. The restaurant also delivered most of the orders to individual residences to comply with social-distancing measures. Through meal orders and donations, we raised over \$500 for the Family Centered Care Program.

Jewish Identity

A Message from the Mu Chapter Advisor

I hope all of you and your families are doing well. I am extremely proud of our undergraduate brothers for their ability to conduct a very successful rush during the pandemic and initiate 14 new brothers. Our chapter's brothers continue to excel academically, in their extracurricular activities and with philanthropy. It has been a privilege to serve as our chapter advisor for the past 18 years (including as a co-advisor with Dr. Jay Levine from '03 – '05), and I intend to continue volunteering in this role for the foreseeable future. As a Crozet resident, it's convenient to live only 20 minutes from our Grady Ave.



house. Rather than just communicating by phone and e-mail, this proximity allows me to meet in person with the executive board and other brothers as needed and to annually attend (at a minimum) and speak at chapter meetings.

I am very pleased to announce that our Mu Chapter is kicking off a \$50,000 capital campaign led by the current brothers and with my assistance. As many of you know, our [Alpha Epsilon Pi UVA alumni fund](#) is administered by Alumni Hall, and its purpose is to assist our chapter by helping pay for repairs, maintenance and capital improvements that exceed their budget and reserves. Any disbursement requests by the house manager or executive board must be approved by either Jay or myself. No one at AEPi national headquarters has any access or control over our alumni fund. All donations are considered tax-deductible gifts to the University of Virginia.

Our Grady Ave. house (and many other AEPi chapter houses) is part of the corporate entity “University Chapter Fraternal Home Corporation” owned by nationals. Our lessor and property management company is [Esponda Associates](#). Prior to the fall of `18, Esponda Associates funded all repairs and maintenance by including those costs as part of rent. This caused our housing costs to rise substantially above market rates and become unaffordable. In the spring of `18, Jay Levine, myself and Daniel Crystal (the master at the time) negotiated a new housing agreement with Esponda that gave our chapter the control to fund and pay for repairs and maintenance (R & M) with a \$15,000 annual budget goal. In order to lower rent to keep housing costs in line with market rates, the entire R & M budget was funded with an increase in dues to all brothers. Since all brothers use the house, it’s fair that everyone contributes to its upkeep. The downside is that this required our chapter to raise dues to \$1,150 a semester, which is among the highest of UVA fraternities. `21 - `22 Mu housing costs are \$8,000 for a 9 month lease for a single (\$889 a month). That’s \$6,750 in rent payable to Esponda and \$1,250 in utilities payable to the chapter. \$8,000 is 8.1% higher (\$600 more) than comparable UVA housing costs of \$7,400.

In 2019, our house had two flooding events from torrential rains that caused over \$11,000 in damages which required expensive repairs to a heat pump and the need to purchase a new furnace, gas



tankless water heater and sump pump. Our alumni fund helped the chapter with these expenses along with paying for a new basketball pole (fixed in cement), backboard and hoop. These large disbursements depleted our fund. I have donated on an annual basis and contributed \$1,800 earlier this year to replenish it. Our current balance is a very low \$1,783.

Any repair, maintenance or capital improvement expense that exceeds the chapter's ability to pay via house funds and our alumni fund are paid with what Esponda Associates calls "trustee cash." This is an interest bearing, home equity line of credit held by nationals. Borrowing trustee cash causes increases our housing costs. In a worst case scenario, borrowing large amounts of trustee cash would cause our leases to far exceed market rates which would result in brothers unable to afford to live in our house. This would cause us to lose our house and our chapter would fold. Our current mortgage balance is \$390,000 and our trustee balance is \$99,805 for a total for \$489,805 owed to nationals. That includes approximately \$20,000 for a partial roof replacement this summer. As I wrote above, our capital campaign goal is to increase our alumni fund balance to \$50,000. Achieving this goal will prevent our chapter from having to borrow more trustee cash from nationals, it will keep our housing costs affordable and it will help ensure the long term success and viability of our chapter. Significantly increasing our fund balance will also potentially allow our chapter to lower dues. This would make us more competitive in terms of dues relative to other fraternities.
